## Assumption of Risk and Waiver of Liability Relating to Coronavirus/Covid-19

*The club requests all members to take the time to read and understand this document and its implications.*

*This waiver & declaration must be completed prior to or upon visiting and before participating in any activity.*

The novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is known to spread mainly by contact from person to person. Consequently, State and Federal governmental authorities recommend various measures and prohibit a variety of behaviors, in order to reduce the spread of the virus.

Orange Bridge Club Inc. and its members commit themselves to comply with the requirements and recommendations of N.S.W. Public Health, and to put in place and adopt all necessary measures to that effect. However, Orange Bridge Club Inc. cannot guarantee that you will not become infected with COVID-19. Further, attending the activities could increase your risk of contracting COVID-19, despite all preventative measures put in place.

- I acknowledge the highly contagious nature of COVID-19 and I voluntarily assume the risk that I could be exposed or infected by COVID-19 by participating in Orange Bridge Club's activities. Being exposed or infected by COVID-19 may particularly lead to injuries, diseases or other illnesses.
- I declare that I am participating voluntarily in Orange Bridge Club's activities and am not acting under inducement or pressure.
- I declare that neither I nor anyone in my household, have experienced cold or flu-like symptoms in the last 14 days (including fever, cough, sore throat, respiratory illness, difficulty breathing).
- I also declare that I have not travelled and returned from overseas or designated "COVID hot spots" in the last 14 days. Further I have not had contact with a diagnosed, suspected or confirmed case of Covid-19 in the last 14 days.
- If I experience, or if anyone in my household experiences any cold or flu-like symptoms after submitting this declaration, I will not attend any of Orange Bridge Club's activities, programs or services until at least 14 days have passed since those symptoms were last experienced.
- The ABF provides Public Liability to all ABF affiliated clubs in Australia. A condition of the ABF Public Liability Insurance Policy is that clubs must adhere to all Government legislation, law, rules and conditions. Failure to adhere to this condition could jeopardise the Policy. As long as the Orange Bridge Club Inc. is affiliated with the State Bridge Association the policy will extend to them.
- I agree to the requirements and recommendations of N.S.W. Health and to those special safety regulations put in place by Orange Bridge Club Inc. as it pertains to Covid-19 Coronavirus and to adopt all necessary

measures to those effects.

This document will remain in effect until Orange Bridge Club Inc., as per the direction of the N.S.W. Health and their officials, determines that the acknowledgments in this declaration are no longer required.

This document is in addition to and does not replace all other Orange Bridge Club Inc. rules and regulations.
