Message from the Treasurer

A reminder that players are to be seated 10 minutes prior to play commencing. You are requested that your table fees are paid prior to taking a seat. Our volunteers who are on the roster for table fees also play and they get delayed trying to reconcile prior to the session starting if players forget to pay. Consideration for their role is appreciated.

TEACHER'S TALK

The first set of lessons for 2023 has just been completed. Supervised play is on Monday evening from 7pm to 9pm and Wednesday afternoon from 1pm to 3pm for all players who wish to build up their skill base at the Novice level.

DIRECTOR'S CORNER

Insufficient bids:

Players are often tempted to not bother a director and when an insufficient bid is made, make their own ruling at the table with a comment like "you can't do that" and then cross out the bid or bid at the correct level.

Acting at the table before calling the director may lead to the non-offending side forfeiting some of their rights to have an irregularity rectified (Law 11).

Calling the Director provides a broader range of options (Law 27):

• The next player after the insufficient bid has the option to accept the bid and the auction can proceed in the usual way;

- If the insufficient bid is not accepted, that player now has three options
 - Correct the bid to the lowest sufficient level which specifies the same denomination (suit or NTs) and the bidding continues as if no wrong had occurred
 - Correct with a comparable call (see following) and the bidding continues as if no wrong had occurred
 - Make any other sufficient bid or pass but partner must pass whenever it is their turn to call.

What is a comparable call?

Law 23 (A) Definition

A call that replaces a withdrawn call is a comparable call if it:

- 1. Has the same or similar meaning as that attributable to the withdrawn call, or
- 2. Defines a subset of the possible meanings attributable to the withdrawn call, or
- 3. Has the same purpose (e.g. an asking bid or a relay) as that attributable to the withdrawn call.

How does a player figure out what a comparable call might be?

It is useful for a director to take the player who made the insufficient bid away from the table when this situation arises to avoid unauthorised information as the player clarifies their options.

The director does not need to find a comparable call. The player does

that and may, if they wish, ask the director how he would rule if his choice of replacement call was made.

Often there will be no comparable call available in the offender's system. Comparability is measured against systemic agreements.
